#### **RESOLUTION NO. TMP-23-1427**

## APPROVING FY24 OPERATIONS AND MAINTENANCE AGREEMENT WITH USGS FOR THE STREAM AND RAINFALL GAGES

WHEREAS, on October 13, 1998, the Kane County Board passed Ordinance No. 98-251 adopting the Kane County Stormwater Management Plan pursuant to 55ILCS 5/5-1062, which established goals to "identify, protect, and improve floodplains, waterways, lakes, ponds, wetlands...in order to maximize the protection of public health, safety and welfare;" and

WHEREAS, the collection of rainfall and streamflow data is an integral part of planning flood mitigation activities, investigating water quality, and protecting and improving Kane County's water resources; and

WHEREAS, on May 12, 1998, the Kane County Board passed Resolution #98-129 authorizing the expenditure of funds to install, operate and maintain stream and rainfall gages in cooperation with various state and federal agencies, including the United States Geological Survey (USGS) and the Illinois Department of Natural Resources; and

WHEREAS, the County has negotiated joint funding with the USGS for the 2023-2024 operation, maintenance, and monitoring of gages in Kane County under and annual Joint Funding Agreement effective as of October 1, 2023; and

WHEREAS, adequate funds to fulfill this agreement are budgeted for FY2024 and exist in 355.668.66856 for Kane County's commitment of Sixty-Nine Thousand Two Hundred Sixty Dollars (\$69,260).

NOW, THEREFORE, BE IT RESOLVED that the Kane County Board by the Kane County Board that the Chairman is hereby authorized and directed to enter into a contract with the USGS to jointly fund the operation, maintenance, and monitoring of rain and stream gages in Kane County in an amount not to exceed Sixty-Nine Thousand Two Hundred Sixty Dollars (\$69,260) to be paid from 355.668.66856 pending the approval of the FY2024 Budget. A copy of the Joint Funding Agreement shall be kept on file with the Kane County Auditor.

In December 2022, The Metropolitan Mayors Caucus and ComEd announced 16 Illinois communities, including Kane County, will receive training and assistance in a new Electric Vehicle (EV) Readiness program. Funded in part with a \$225,000 commitment from ComEd, the EV Readiness program will help municipalities streamline policies, meet the growing demand for EVs and charging infrastructure, and implement best practices for safe and effective regional transportation electrification. A second cohort was announced in August of 2023 comprising an additional 15 communities. Our aim is to advance transportation electrification in the region and make it faster, easier, and more affordable for our residents and businesses to install EV charging stations in our community. In Kane county alone the number of EV cars has nearly quadrupled from an estimated 739 in 2019 to 3302 in September 2023.

Joining the cohort will allow us to address these high-level Greenest Region Compact (GRC) goals:

- Support efficient transportation that uses resources wisely.
- Integrate sustainability into transportation policies, programs, and regulations.
- · Promote sustainable transportation choices.
- · Maintain a diverse, safe and efficient transportation network.
- · Operate a safe, clean, and efficient fleet.

### Rebates and Incentives

- Federal Tax Credit for Vehicles: Use the federal government's federal tax credit tool to learn about the credit amount available for various EV makes and models. The maximum credit is \$7,500 for new vehicles and up to \$4,000 for used vehicles.
- New and Used Clean Vehicle Tax Credits, Energy Saver webpage This Department of Energy webpage describes the new and
  previously owned clean vehicle tax credits. The page includes a <u>checklist</u> to determine if a vehicle is eligible for either credit. You
  may also want to contact a tax professional.
- <u>Illinois EV Rebate Program</u>: The next rebate cycle will be open Nov. 1, 2023, to Jan. 31, 2024. Residents may apply for a \$4,000 rebate on a new or used all-electric vehicle. Purchasers must apply for the rebate during an open rebate cycle and within 90 days of vehicle purchase.
- Federal Tax Credit for EV Charging Equipment Residents who purchase qualified residential charging equipment may receive a tax credit of 30% of the cost, up to \$1,000. Find out more at the above website, or consult a tax professional.



# EVs have several advantages over conventional vehicles:


- Energy efficient. EVs convert over 77% of the electrical energy from the grid to power at the wheels. Conventional gasoline vehicles only
  convert about 12%–30% of the energy stored in gasoline to power at the wheels.
- Lower emissions. In <u>Kane County</u>, greenhouse gas emissions caused by on-road transportation account for 2.2 MMTCO2e or 24% of the total greenhouse gas emissions.
- Electric vehicles can reduce your greenhouse gas emissions from 46-90% depending on the type of electric car, compared to non-electric cars.
- . Improved air quality. Lower emissions lead to better local air quality.
- Performance benefits. Electric motors provide quiet, smooth operation and stronger acceleration.
- EVs do not emit tailpipe emissions, which makes them a cleaner option to operate compared to gasoline or diesel vehicles, especially if
  charged with renewable energy.
- Reduced maintenance costs. EVs have fewer moving parts and don't require oil changes, tune-ups, cooling system flushes, and other
  common maintenance services needed for traditional vehicles.
- · Reduced energy dependence. Electricity is a domestic energy source.
