EXECUTIVE SESSION

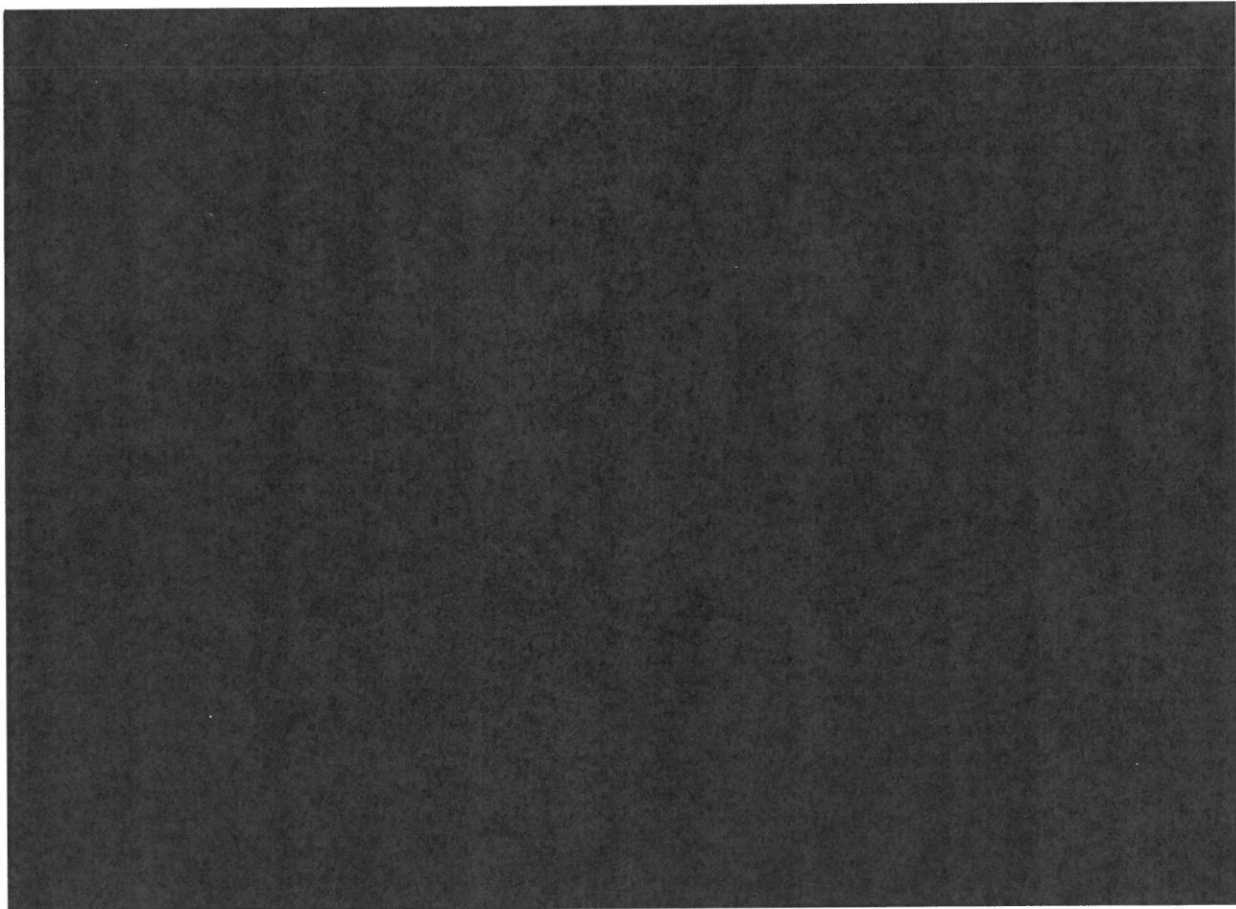

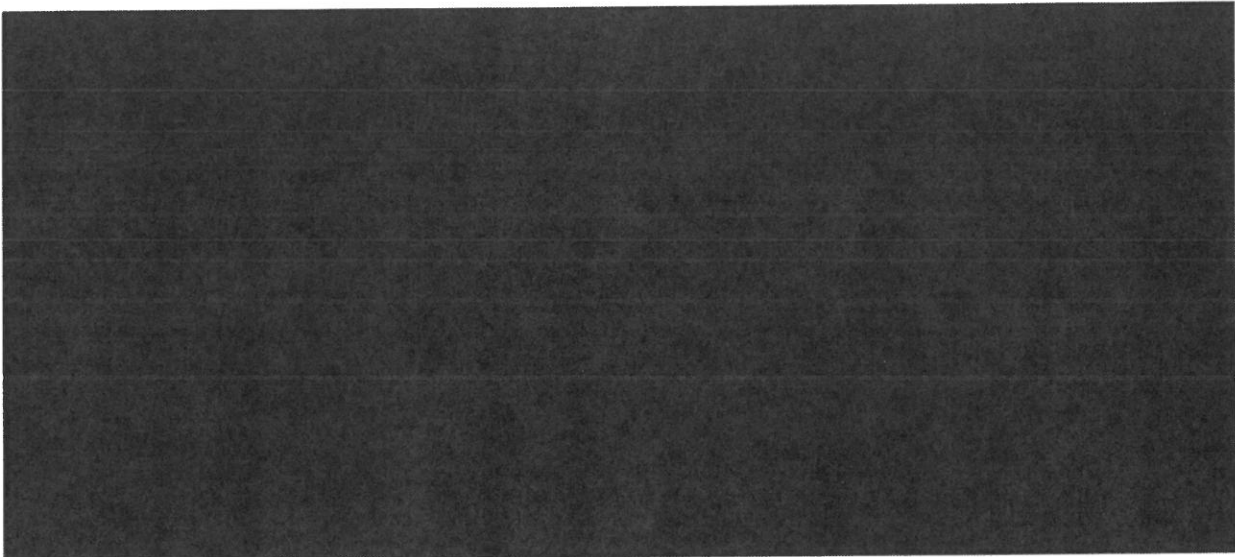
