To remove and replace existing 5 - 1,500 gallon septic tanks found to be deteriorated and cracked posing the concern of possible collapse including:  
 Pumping of 5 - 1,500 gallon septic tanks,  
 Remove and dispose of the 5 existing tanks off site,  
 Install 2 - 3,000 gallon precast concrete tanks and one (1) 2,000 gallon tank, totaling 8,000 gallon,  
 Install risers to finish grade for routine maintenance and cleaning,  
 Install 6" interior baffles with 6" PVC connecting all tanks in the series,  
 Reconnect to existing inlet and outlet pipe with SCH 40 PVC and No-shear mission couplings, per codes,  
 Backfill after Kane County Health Department inspection and approval,  
 Included Kane County permit fees,  
 Prevailing wage - Union,  
 Performance Bond, if required;


