AMENDING RESOLUTION 23-206 TO ADOPT A NEW PROCESS FOR APPROVING LOBBYIST CONSULTANT INVOICES

WHEREAS, by Resolution 23-206, the Kane County Board authorized the Kane County Board Chairman to enter into a professional services agreement with McGuireWoods Consulting, LLC, for a period of two (2) years with the option of two (2) one-year extensions if mutually agreed upon, for professional government relations consulting and legislative lobbying services, at a cost of Ten Thousand Dollars (\$10,000) per month; and

WHEREAS, by Resolution 23-206, invoices are to be approved by the County Board Chairman and reported to the Legislative Committee, Executive Committee, and the County Board; and

WHEREAS, by Resolution 23-206, McGuireWoods Consulting, LLC, reports to the Legislative Committee; and

WHEREAS, the professional services agreement with McGuireWoods Consulting, LLC, provides that "[t]he Consultant will submit to the County an itemized monthly invoice reflecting the work completed within the preceding calendar month and the time spent thereon"; and

WHEREAS, McGuireWoods Consulting, LLC, has been retained as a lobbying organization by the Kane County Board to advocate on its behalf, and their services are of strategic importance to the County; and

WHEREAS, it is essential for Kane County to ensure transparency and accountability in the invoice review and payment process while also having McGuireWoods Consulting, LLC, provide invoices that are consistent with its industry standard invoicing practices; and

WHEREAS, McGuireWoods Consulting, LLC, will continue to report to the Legislative Committee and also provide summary invoices that will provide Kane County with the information it requires for invoice approval; and

WHEREAS, it is necessary to amend the Resolution 23-206 as the Legislative Committee and the Kane County Board seek to establish a consistent, streamlined process for reviewing summary invoices from McGuireWoods Consulting, LLC.

NOW, THEREFORE, BE IT RESOLVED that the Kane County Board amends Resolution 23-206 and adopts the following measures to for the review and approval of invoices received from McGuireWoods Consulting, LLC: 1. Kane County Legislative Committee Chair(s) will accept summary invoices from McGuireWoods Consulting, LLC, that shall be considered adequate for payment processing while maintaining consistency with McGuireWoods Consulting, LLC's industry standard invoicing practices.

2. Upon receiving the summary invoices, the Legislative Committee Chair(s) shall review and verify the services provided by McGuireWoods Consulting, LLC, for accuracy and compliance with contractual agreements. If the Legislative Committee Chair(s) deems the summary invoices acceptable, they shall forward them to the Purchasing Department for payment processing.

3. The Purchasing Department shall be responsible for processing payments based on the reviewed summary invoices in a timely manner, ensuring compliance with all applicable statutory, regulatory, contractual, and County procedures.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Kane County Board that this resolution shall be effective immediately upon passage, and the Legislative Committee Chair(s) and Purchasing Department are directed to take all necessary actions to implement these changes.
