

FIRST AMENDMENT TO ACCESS LICENSE AGREEMENT

WITNESSETH:

WHEREAS, the Forest Preserve District of Kane County, and T-Mobile Central desire to enter into an access license agreement, which said Agreement is attached hereto and made part of hereof as Exhibit A; and

WHEREAS, the parties to desire to amend paragraph 2 of the Access License Agreement concerning the terms of the agreement.

NOW THEREFORE, the parties agree to amend Paragraph 2 as follows (new terms indicated by underline):

2. TERM. The easement, rights, and privileges herein granted shall be for a maximum term of fifteen (15) years. The initial term of this License shall be for Five (5) years beginning on November 1, 2026 and continuing through November 30th 2031 so long as the Licensee abides by the covenants, conditions and terms of the License herein. Provided Licensee is not then in default hereunder, this Agreement shall be extended for a successive five (5) year term at the expiration of the initial five (5) year term and then again for a second successive five (5) year term at the expiration of the initially extended term ending November 30, 2041. If abandoned by the Licensee at any point, the access license agreement hereunder shall terminate.
