6. Treasurer's Report (C. Lauzen)

A. Monthly Report

Treasurer Lauzen stated the monthly Treasurer's Report was on file. He hoped to have a special guest speaker, Investment Manager Neil Powers, to speak at today's meeting. Mr. Powers was one of the investment managers selected through the County's Request for Proposal (RFP) process. However, Mr. Powers will give his presentation at a later meeting. Lauzen explained that the Treasury continues to collect taxes and earned interest. He suggested to the Finance Committee that they work with the County's external auditor, Baker Tilly, on the policy issues regarding the allocation of interest income. Lauzen addressed questions and comments from the Committee. Discussion ensued.

She shared that the County has approximately five expired Collective Bargaining Agreements (CBA), with four of them being expired for over a year.

V. Authorizing the Creation of a Special Revenue Fund for the Processing of Additional Compensation or Stipends for Certain Elected Officials and Department Heads

Committee Member Lenert requested additional information on this resolution. Fin. Exec. Dir. Hopkinson explained that certain elected officials receive a stipend or additional compensation from the State each year. Historically, the State would pay the compensation/stipend. Afterwards, the State would send a check to the local governments and then the County would pay the FICA and IMRF. Illinois has changed this law. Now, the State will send a check to the County for the full amount of the stipend/compensation, and the County will be responsible for distributing that amount directly to the elected officials. The stipends/compensation will be held in a required special fund. Hopkinson
