A. Monthly Report

KCAC Admin. Youngsteadt announced that the first Vaccine Clinic will be held on Saturday, April 27, 2024 from 10:00 a.m to 1:00 p.m. The "drive-thru" style will continue to be an option for pet owners. He announced that a microchip clinic event will be held on Saturday, May 11, 2024 from 8:00 a.m. to 12:00 p.m. at Carpenter Park in Carpentersville, Illinois. The cost of a microchip is \$15. Youngsteadt addressed the option of a therapy dog for the Kane County Government Center. He communicated Kane County Animal Control's (KCAC) support for the idea, with the exception of a dog passing a behavioral test and completing all medical evaluations first. Much discussion ensued.

9. Executive Director Report (M. Isaacson)

A. Health Department Updates

KCHD Exec. Dir. Isaacson announced that the completion of the Community Health assessment process is almost finished. The health department continues to monitor the measles disease in the Chicagoland area, and are making sure exposed individuals seek medical care.

Div. Dir. of Health Onwuta explained the importance of vaccinations, and making sure individuals know where their vaccination clinics and information are located. She stressed the importantance for people to have proof of vaccination. Onwuta noted that since the beginning of March, Chicago has given out 15K vaccinations to contain the measles outbreak.

B. Kane County Health Department Tobacco Cessation and Prevention Initiatives

KCHD Community Health Coordinator Nathan Ritzema shared information on the Tobacco Cessation and Prevention Initiatives. He stated that tobacco is a huge cause of premature death in half a million Americans each year. Ritzema pointed out that the use of E-cigarettes are equally addictive and dangerous. They contain nicotine, and are not a healthy replacement for cigarettes. The percentage of middle school students who vape is significantly higher than the national average. Ritzema mentioned the Smoke Free Illinois Act, which protects residents from harmful effects of exposure to secondhand tobacco smoke and e-cigarette vapor. He also highlighted the Illinois Tobacco Quitline which is a free resource for those who seek substance support.

Health Promotion Mgr. Tina Koral stated that the Vape-Free program brings schools, parents, students, and the health department together, in an effort to curb vaping initiation among Kane County middle school and high school students. This will benefit schools by reducing vaping initiation rates, reducing disciplinary actions due to vaping on campus, and classroom disruptions from students leaving class to vape. Koral stated that there is sponsored training and supplies offered to teachers, and encourage communication and collaboration between schools and parents.
