C. Staff Updates on Kane County Economic Development Initiatives

JEG 360, LLC CEO, Grueling, stated that the Articles of Incorporation for the Kane County Economic Development Corporation were filed with the Secretary of State, and approved by the State of Illinois. There are now approved articles, and a federal tax identification number. The final step will be to file for tax exempt status with the Internal Revenue Service. Grueling noted that there is now a founding board of members including Steve Pitstick, Sean McCarthy with Comcast, and Austin Dempsey with Batavia Enterprises. Once the agreement with the County is executed next week, additional Board Members can be recruited, as well as municipal representation. Grueling anticipates a strong economic development future for Kane County. Discussion ensued.

7. Office of Community Reinvestment - Workforce Development Division

A. WIOA Year-End Performance Report

Committee Chairman, Lewis, announced that the guest speaker was not able to attend the meeting today. This presentation was rescheduled to next month's meeting.

B. OCR Financials

Community Reinvestment Dir., Berger, announced that the monthly reports are on file. He provided a status report of the current program year. The program came to a close on June 30, 2024. The total amount expended from the 2022 grant was \$2.1M in PY2022 funds. The total amount expended for the PY2023 grant was \$4.5M. The total fiscal benchmarks were exceeded at 80%. For direct training, the total amount was achieved at 55%. The total amount of funds exceeded for youth and work based learning was achieved at 35%. There was 62% of Kane County enrollment, 19% from Kendall, and 19% from Dekalb. All obligations and requirements were met.
