## Overview

Planning Division Staff met with Committee leadership to discuss potential goals for the Kane County Agriculture Committee to pursue for 2026.

The goals are intended to guide the Committee's actions throughout the year, responsive to community needs and consistent with County policies and priorities on agriculture and food access.

The following 5 goals were drafted for further review and discussion by the

Committee.



## 1. Farmland Protection



Oversee the implementation of Kane County's Farmland Protection Program, increasing total acreage preserved for farming, improving access to farmland for future generations, and exploring new conservation strategies.

## 2. Growing for Kane







Direct activities aligned with the Growing for Kane Program that support Kane County's food growers with funding, technical expertise, and policy improvements to make healthy, locally grown foods more accessible.

## 3. Funding Advocacy



Advocate for funding to advance initiatives that support thriving farm businesses and strengthen Kane County's agricultural sector.

## 4. Staff Oversight



Provide oversight of County staff administering projects and programs that address the needs of farmland preservationists, agricultural businesses, food assistance organizations, and residents with limited access to fresh grown foods.

## 5. Raising Awareness of Agriculture



Raise community awareness of the value of agriculture in Kane County for providing economic benefits, opportunities for land stewardship, a sustainable source of healthy foods, and maintaining a historic rural heritage.

#### **ORDINANCE NO. TMP-25-1430**

## AMENDING SECTION 2-48 OF THE KANE COUNTY CODE (STANDING COMMITTEES) TO REVISE LANGUAGE RELATED TO THE AGRICULTURE COMMITTEE

WHEREAS, section 2-48 of the Kane County Code governs the standing committees of the Kane County Board; and

WHEREAS, the Kane County Board desires to amend sections 2-48(A)(13) of the Kane County Code to revise language related to the Agriculture Committee; and

WHEREAS, the Agriculture Committee of the Kane County Board has reviewed and recommended changes to section 2-48 of the Kane County Code, which includes affirming the Committee's role in overseeing policies and initiatives that protect farmland and support local food access; and

WHEREAS, section 2-52 of the Kane County Code provides that no amendment shall be made to Division 2, Article II, Chapter 2, of the Kane County Code without the consent of the majority of the total membership of the County Board, nor on the day of introduction of the same.

NOW, THEREFORE, BE IT ORDAINED by the Kane County Board that Kane County Code, Chapter 2 (Administration), Article II (County Board), Division 2 (Rules of Order), Section 2-48 (Standing Committees) is hereby amended to read as follows (underline indicates insertion of text; strike-through indicates deletion):

A. Generally: The standing committees of the County Board, each to consist of seven (7) members unless otherwise provided, shall be as follows:

13. Agriculture: This committee shall <u>provide oversight of the County's efforts to protect</u> farmland and support local food access, and have jurisdiction to offer assistance and technical expertise to other <u>organizations</u> county agencies, municipalities, departments and offices to address concerns unique to agriculture. Recognizing that agriculture is the second <u>a</u> leading industry in Kane County <u>and is a land use in all 15 townships</u>, this committee will meet periodically with organizations and groups representing farming interests to propose <u>policies and programs</u> guidelines to the County Board as needed.
