8. Executive Director

A. Kane County Children's Mental Health System of Care Parent Council Members

KCHD Exec. Dir. Isaacson announced the members of the Kane County Children's Mental Health System of Care Parent Council. Children's Health Manager, Kate McCormick, stated that their parent and caregiver leaders are apart of a group called Parent Council. Their goals are to life parent's voices through education, outreach, and advocacy. The council include parents and caregivers advocating for the health and wellbeing of young children. McCormick introduced Sara Gonzalez, the lead organizer for Community Organizing and Family Issues. McCormick pointed out that lifting parent and caregiver's voices is vital. Parents bring accountability, urgency, and real world experiences utilizing mental health services for their children. The Parent Council is made up of 20 parent leaders, primarily from Elgin and Aurora. In December, the Parent Council received the "Partner of the Year" award from the Companeros en Salud/Partners, for their work supporting both behavioral health providers and for providing therapy support groups to the community.

B. Health Department Updates

KCHD Exec. Dir. Isaacson provided the Health Department updates. He indicated that there are a fair amount of hospitalizations with respiratory viruses, such as Covid, flu, and RSV. He encouraged everyone to be up to date on their vaccines, and if you are sick to stay home. Over the next several months, Isaacson will be meeting with board members, individually, to get their input on health-related needs within their districts. Isaacson shared an overview of the health departments history and their overall goals. He indicated that as the county moves forward with planning a new health department building, there would be value in having it located in a more centralized area. It is essential to provide more services to the community. He noted that the health department is primarily grant funded. Each grant has a specific timeline and deliverable and operates on a balanced budget. Isaacson shared a graph illustrating all of the health department's divisions, departments, and their current funding structures. A newly formed division, Planning and Information Management, was created within the last year as part of an effort to increase their ability to provide real-time data to community partners. Isaacson reviewed the cycles of various diseases and the different ways they can be transferred, such as susceptible hosts, pathogens, reservoirs, portals of entry, mode of transmission, and portal of exit. Isaacson reviewed the Adverse Childhood Experiences (ACES). He stated that young people can be exposed to certain things, which can increase the risks for a negative outcome and life-long affects. The number one area to focus on is early childhood and supporting families. With a new health facility, it will provide the space to bring residents in, increase services for communicable diseases, both for education and outreach, and provide more space for staffing. It will also create a community hub for connection, education, and training for residents and partner organizations. Additionally, the new facility will increase support services to help residents avoid, respond to, and recover from negative situations. He explained that a community health assessment drives efforts to identify priorities and funding streams for improved services, such as behavioral health, community education, and senior services. They are working on grant writing and legislation opportunities to increase public health funding state-wide. Isaacson addressed questions and comments from the Committee. Much discussion ensued.

Committee Member Young shared an article from January 10, 2024 found in the Western Journal.
