## AUTHORIZING JUDICIAL FACILITY CONSTRUCTION FUNDS FOR GENERAL CONSTRUCTION SERVICES WITH MRRW CONSTRUCTION (BID# 23-032)

WHEREAS, Kane County is currently in contract with MRRW Construction Services per Resolution No. 23-285 (BID#23-032) to cover construction projects which cannot be performed inhouse by County staff; and

WHEREAS, Resolution No. 24-118 approves Six Hundred Thousand Dollars (\$600,000) per fiscal year; and

WHEREAS, the Kane County Building Management Department has additional project needs for 1.) Building bathrooms at the KCDC for the Diagnostic Center employees and 2.) Converting Courtroom 150 to the jury check-in room, improving lighting, and building a new entryway to the back of the Third Street Courthouse, and other various projects for General Construction Services in the amount of Four Hundred Forty-Nine Thousand Seven Hundred Ninety Dollars (\$449,790); and

WHEREAS, adequate funds are available in the Judicial Facility Construction fund.

NOW, THEREFORE, BE IT RESOLVED by the Kane County Board that the Chairman thereof is hereby authorized and directed to enter into agreement with MRRW for Project 1.) Building bathrooms at the KCDC for the Diagnostic Center employees in the amount of Ninety-Six Thousand Dollars (\$96,000) and Project 2.) Converting Courtroom 150 to the jury check-in room, improving

lighting, and building a new entryway to the back of the Third Street Courthouse in the amount of Two Hundred Seventy-Eight Thousand Eight Hundred and Twenty-Five Dollars (\$278,825), with a 20% contingency in the amount of Seventy-Four Thousand Nine Hundred Sixty-Five Dollars (\$74,965) for a total of Four Hundred Forty-Nine Thousand Seven Hundred Ninety Dollars (\$449,790).
